### Purpose:

To review the proposed Refresher Program and approve for implementation.

### Background:

Amendments to the College of Opticians of Ontario's (the "College") [Registration Regulation](#) came into effect on July 1, 2024, and the new regulation states that individuals who fall into one of the following three categories must complete a refresher program in order to maintain, transfer to, or be granted a certificate of registration with the College as a Registered Optician ("RO"):

- 1) **Registered Opticians who do not meet currency requirements.** Registered Opticians (RO) who do not fulfil the currency requirement will have the option of transferring into the Inactive Class, completing a refresher program or resigning their registration.
- 2) **Registrants wishing to change from the Inactive Class to the Registered Optician class.** As per the [Reinstatement and Changing from Inactive to Active Practice Policy](#), in order to resume active practice, Inactive Opticians will be required to demonstrate that their knowledge and skills are current. Inactive registrants who cannot demonstrate recent practice hours (gained before going inactive or in another jurisdiction), have the option of completing a refresher program that has been set and approved by the Registration Committee.
- 3) **Intern Opticians who have not completed their opticianry program or the examinations within 18 months of the date of their application** and who have not practiced in a manner that would demonstrate they would meet the standards of practice. In this case, in order to be granted a certificate of registration as an RO, the applicant must successfully complete a refresher program or undergo a professional competency assessment.

The Registration Committee reviewed a proposed Refresher Program (Appendix A) at their May 12, 2025 meeting. Upon review and discussion, the Committee agreed that it was important to seek feedback from registrants. The proposed Refresher Program was posted on the College's consultations webpage along with an explanatory note and a survey link for feedback to be provided. The proposed model was circulated via e-blast to registrants (Registered Opticians, Inactive Opticians, Intern Opticians) on July 25, 2025. Individuals were invited to answer survey questions and to provide any comments by 11:59pm August 24, 2025 (31 days). The invitation was also extended to suspended opticians.

A total of 42 responses were received. A summary of the survey results together with comments received, is attached for the Board's review as Appendix B.

### *Stakeholder Feedback*

29 of those who completed the survey identified as a Registered Optician (69.05%). Other respondents included 12 Inactive Opticians (28.57%), and 1 who identified as "other" (2.38%) – an Intern optician.

When asked what their overall opinion of the proposed refresher program was, 30 respondents thought it was a good idea, 5 disliked it, 5 would like changes, and 2 responses fell in the other bucket.

Comments from those who like the proposed refresher program included:

- *This is a through program that will ensure that the public is protected through maintain a high level of skill set in opticians returning to practice after a break. I appreciate that there are different levels of upgrading based on time out of practice.*
- *I like the proposed refresher program, it's a good idea.*
- *I think the proposed refresher program is a fair and practical approach. I appreciate the tiered system based on how long someone has been out of practice, and I like that the modules are online and can be done at my own pace. It's good to see the focus on public safety without making the process too difficult or expensive. Overall, it feels supportive and reasonable*
- *Seems logical.*
- *After reading the refresher program description, it seems to be well thought out in terms of knowledge required after specific time periods of absence from the profession.*

Comments from those who disliked the proposed refresher program included:

- *Too costly*
- *i think it is silly to have to take a refresher program if you are an inactive member. you're still paying the college your yearly dues, and have to complete your CE credits to maintain that status. this sounds like an absolute money grab, especially since you're already brushing up on your opticianary skills doing those said CE credits.*
- *I was incredibly disappointed in this decision.*

- *For interns it is a good idea , for licensed audits, whether they have been practicing or not it's absolutely ridiculously stupid, you're going to have a 50-year-old optician who's probably being licensed for 25 years who maybe had to take a couple years off for a illness go through a Reef refresher course? And let me guess this is gonna cost people money, right?*

Comments from those who would like changes to the proposed refresher program included:

- *Programs should only be implemented after five years. 3-5 years don't erase what you've done most of your life. The first level can be started after 5 years. Upon registering, members should be welcomed and emailed a newsletter with any changes to our standards.*
- *Are the NACOR courses substantive enough for those that have been out of practice for a period of time. Considering adding product knowledge and fitting techniques for new products.*
- *If the Optician can prove they practiced in another Canadian province they should not need to take any refresher to be an RO again in Ontario ( just pay the relevant registration fee, pro-rated to the time in the year they requested) as well as any administration fees. Additionally if you can prove you worked in another country in the field of Optics and had core competencies like dispensing, no need to to do refresher courses.*  
*If the Optician or intern has been out of the profession for 12 months or longer then yes a refresher course should be required.*

The majority of respondents (26 respondents or 61.90%) felt that the proposed refresher program is fair and reasonable. 8 (19.05%) were unsure and 8 (19.05%) indicated "No". Respondents were encouraged to provide comments if they believed that the proposed refresher program is unfair and/or unreasonable.

Comments included:

- *Former Registered optician already has the ability to practice.*
- *it is unreasonable for someone who is stepping away from being an optician but still paying dues and doing CE credits to keep the status of inactive optician. your knowledge doesn't just magically go away after a year, 5 years, or 10 years of inactivity. regulations don't change often if not at all. it sounds like a complete money grab and a waste of someone's time.*
- *Its not fair for someone whose on maternity leave to come back having to take refresher course again adds more stress as its already is.*

27 (69.23%) respondents agreed that the topics covered in Refresher Level 1 are appropriate for those looking to return to the Registered Optician class from Inactive status after a short period (under 3 years). 3 (7.69%) respondents were unsure. Respondents who disagreed were asked what changes should be made.

Comments included:

- *if someone is inactive for a short amount of time but still doing ce credits to keep their inactive status they should not have to do the refresher course at all. as i said earlier someone's knowledge doesn't just magically disappear.*
- *Start the 1st level after 5 years.*
- *No need to take refresher program as long as they complete the QA credits annually.*

- *In addition to the topics covered in Refresher Level 1, there should also be CE credits from each of the four categories required.*

25 (67.57%) respondents agreed that the topics covered in Refresher Level 2 are appropriate for those looking to return to the Registered Optician class from Inactive status after 3 – 6 years. 8 (21.62%) respondents were unsure. Respondents who disagreed were asked what changes should be made.

Comments included:

- *Not have it.*
- *No change.*

23 (65.71%) respondents agreed that the topics covered in Refresher Level 3 are appropriate for those looking to return to the Registered Optician class from Inactive status after 6 – 10 years. 7 (20%) respondents were unsure. Respondents who disagreed were asked what changes should be made.

Comments included:

- *Refresher Level 3 consider swapping our anatomy and optics for DEI and Communication/Professional Practice.*
- *More than refresher courses on site experience is the best.*
- *When someone is close to 10 years absent from the profession, I believe that they should also have to complete practical on the job hours as part of their reentry that are verified by a current licensed optician.*

The majority of respondents (20 respondents or 57.14%) think the cost of the proposed Refresher Program is fair and reasonable. 9 (25.71%) respondents were unsure. Respondents who disagreed were asked what changes should be made.

Comments included:

- *Cost should only apply to a non practicing or non current status. I dont think an optician currently practicing in another province, whom has paid their dues and provided their yearly required credits should have to pay nor take any type of refresher to obtain or transfer their license with the COO.*
- *You need hands on and in person skills to get back into shape, not go through a college course program that we already spent years completing.*
- *the program is very expensive or time-consuming, making it hard for someone who's already unemployed. If it's being used as a barrier to rehiring rather than genuinely helping you.*

**Additional comments received included:**

- *Not only should this be considered for inactive but any optician who hasn't practiced in an area for a number of years, for example someone who has not fit contact lenses for many years who is going to be fitting again due to a change in practice environment.*

- *With a practice absence of more than 10 years, assuming there is no CE or other optical study done during this absence, the CGA and modules to fill in the gaps are a good start. However, the College should consider having an individual in this situation complete a semester of the optical program and retake provincial licensing exams as well.*
- *Concerned that entry level may be too easy for an experienced optician and the refresher may be perceived poorly.*
- *I think the programs should be kept to a minimum necessary, basically to new jurisprudence and the College's newer regulations. It should also reflect how many years had one actively dispensed, any complaints or disciplinary actions. Maybe there should be some hours of supervised practice.*
- *Please do it.*
- *stop being greedy. a refresher course is not needed for most professionals. people are just going to want to drop their license if they have to do this meaning less dues and less money for the college. total money grab.*

The Committee inquired whether the response rate was typical for stakeholder consultation and noted that it seemed low. College staff noted that the response rate was lower than expected, and that it may be partially due to registrants not grasping how they may be affected by the program and that responses tend to be lower in the summer.

#### *Addressing Concerns Raised in the Feedback*

The Committee examined each concern raised in the feedback to confirm whether the proposed Refresher Program needed to be adjusted based on those concerns.

Concern: Out-of-province hours not counted.

- Out-of-province practitioners will not be affected as experience obtained outside Ontario may be used.

Concern: It is unnecessary for Opticians who have been in practice for a long time and inactive for a brief period of time to complete a Refresher Program.

- it is a standard requirement for health care practitioners to demonstrate currency.

Concern: Cost.

- The program is priced at cost-recovery levels to ensure accessibility and is free for registrants out of practice for less than 3 years. This cost is significantly reduced as under the previous regulation, any individual who was out of practice for less than 3 years automatically had to undergo the competency gap analysis at the cost of approximately \$700. The Inactive class is also now available as a cost-saving option to those who plan to be inactive for a longer period of time. Moving to the Inactive class instead of using the Refresher Program to maintain currency is another way for registrants to keep their costs down.

Concern: Unfair to have the Refresher Program in addition to CE requirements.

- The Refresher Program will only apply to registrants practicing under the currency requirement of 500 hours in 3 years.

Concern: Refresher Program Level 1 threshold should be 5 years and not 3 years

- Three years was selected as the threshold based on environmental scans of other health regulatory bodies. The Refresher program is tiered to account for the different degrees of skill loss.

Concern: Travel expenses

- The Refresher Program is on-demand and can be completed on the registrant's schedule, from whatever location they wish, as it is virtual.

Concern: Seasoned practitioners shouldn't have to do the Refresher Program.

- Healthcare practitioners are expected to keep their skills and knowledge current.

#### **For Consideration:**

As noted above, the new regulation requires the College to create a refresher program in order to maintain, transfer to, or be granted a certificate of registration with the College as a Registered Optician.

Based on the feedback received, the Board is asked to consider whether they would like to approve the proposed Refresher Program.

#### **Public Interest Considerations:**

The majority of respondents supported the proposed Refresher Program and its aim at making sure that if a registrant is listed as "Entitled to Practice" on the public register, the public can trust that the optician's skills and knowledge are current.

#### **Diversity, Equity, and Inclusion Considerations:**

Respondents did not identify any accessibility issues with the proposed Refresher Program.

19 (54.29%) respondents didn't foresee any challenges in completing the proposed program. 4 (11.43%) respondents indicated they foresaw challenges and 12 respondents (34.29%) were unsure. Those who foresaw challenges were invited to elaborate.

Comments included:

- *Babysitting and cost of travel expenses and being out of work.*

The Refresher Program is on-demand and can be completed on the registrant's schedule, from whatever location they wish, as it is virtual. The program is priced at cost-recovery levels to ensure

accessibility and is free for registrants out of practice for less than 3 years. This cost is significantly reduced as under the previous regulation, any individual who was out of practice for less than 3 years automatically had to undergo the competency gap analysis at the cost of approximately \$700.

**Risk Management Considerations:**

From a risk management perspective, public protection remains at the forefront of this proposed Refresher Program. The program will help ensure that registrants who are looking to return to active practice are current in their knowledge. The tiered Refresher Program is designed so that the longer the registrant is away from practice, the more topics they would need to familiarize themselves with. The Refresher Program is not designed to be an income generating stream but a program to assist registrants in maintaining their professional knowledge.

**Action Required:**

That the Board approve the proposed Refresher Program for implementation.

### Details of the Proposed Refresher Program

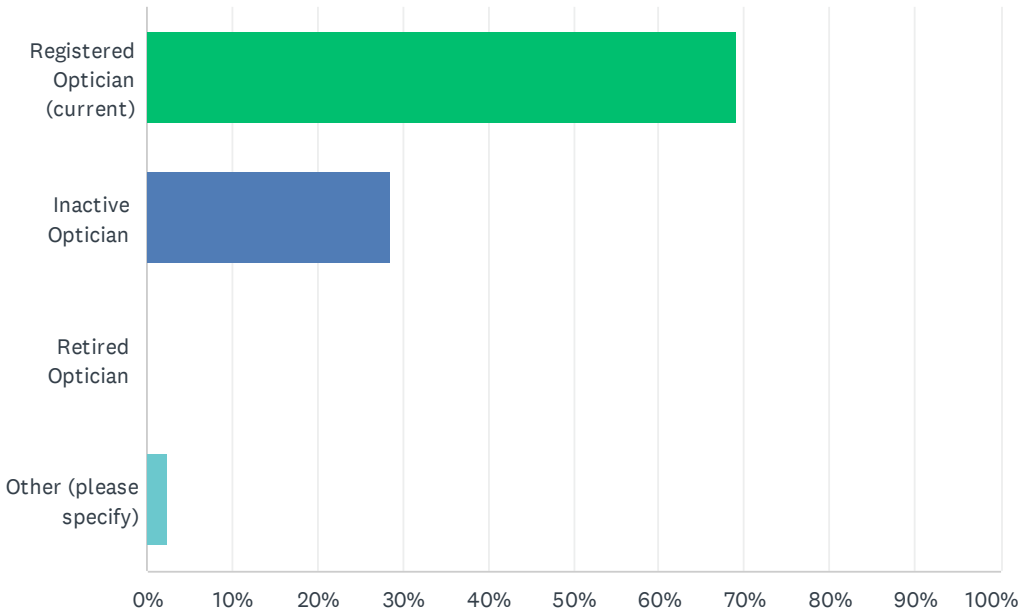

The chart also identifies those who will be required to undergo a Competency Gap Analysis instead of completing a refresher program, due to a lengthy passage of time since they were last actively practising.

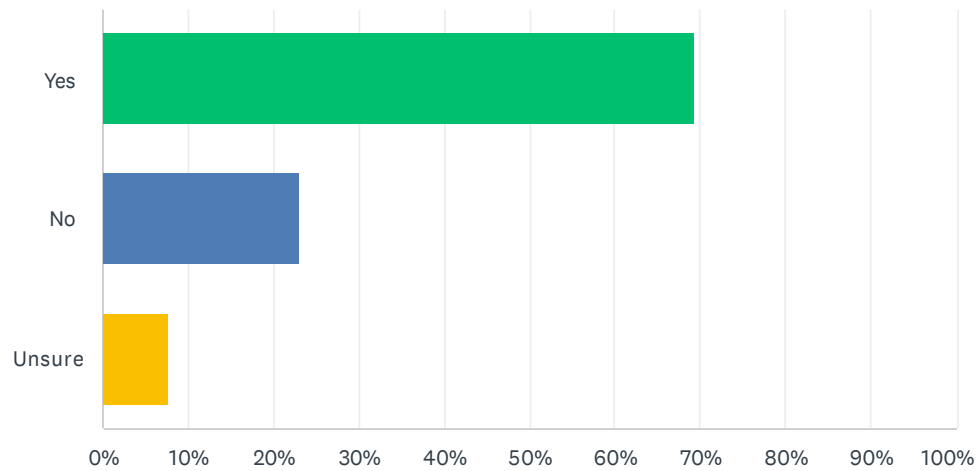

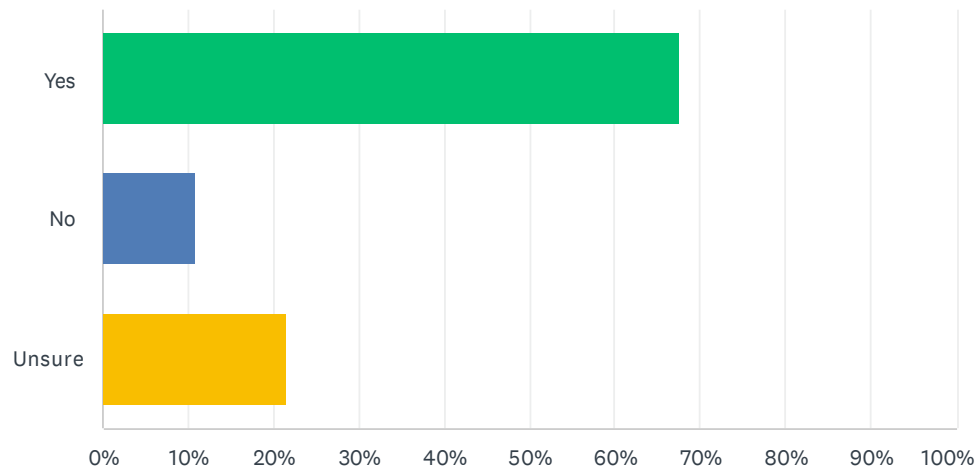

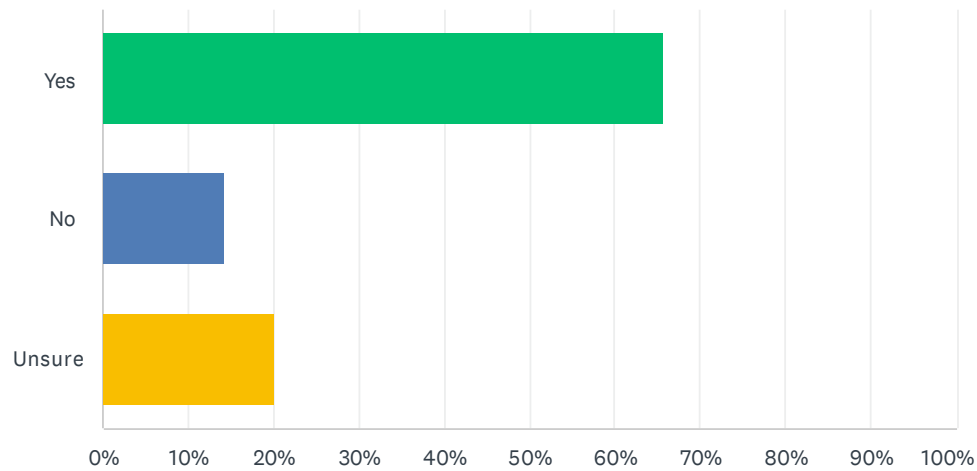

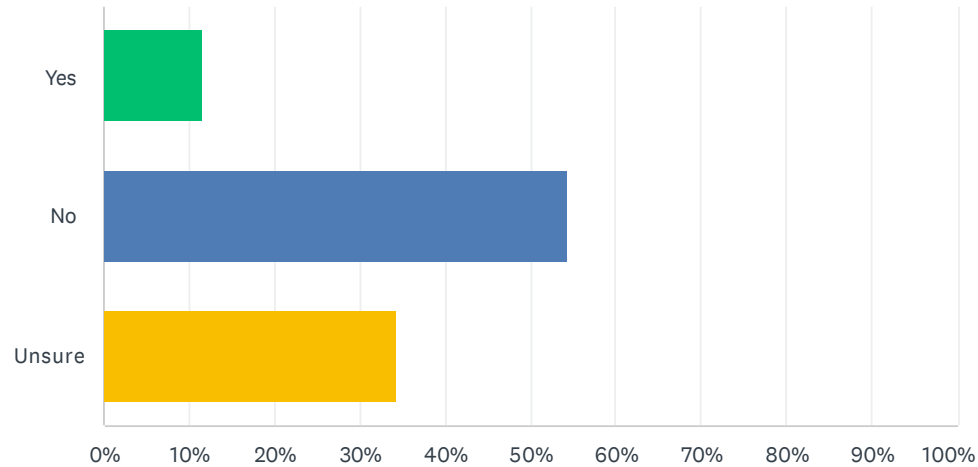

## REGISTRATION POLICY

### Reinstatement and Changing from Inactive to Active Practice

---

This policy applies to all registrants who wish to reinstate a certificate of registration that has been suspended for non-payment of fees (non-renewal), or to change their status from Inactive to Registered Optician.

#### Reinstatement

Reinstatement refers to the process for re-issuing a certificate of registration that has been suspended for non-payment of fees/non-renewal.

The process for reinstatement of a certificate of registration that has been suspended for non-payment of fees is outlined below. It is important to note the following:

- **Registrants must meet all requirements and pay fees:** For reinstatement to occur, registrants must meet the requirements for reinstatement outlined below and pay any required fees. This includes demonstrating that their knowledge and skills are current. A refresher program is available for registrants who are not able to demonstrate the minimum number of recent practice hours.
- **Reinstatement must be to the same class as before:** A registrant may only be re-issued the same certificate that they held prior to being suspended. In other words, a registrant who held a certificate of registration in the Registered Optician class must be reinstated into the Registered Optician class and a registrant who held a certificate of registration in the Inactive class must be reinstated into the Inactive class. Once reinstated, registrants will be permitted to change into a different registration class.
- **Certificates suspended for more than 3 years will be revoked:** Under the Registration Regulation, opticians whose certificates of registration have been suspended for non-payment of fees have a three-year window in which they can apply for reinstatement. Opticians who do not reinstate their registration within the three-year period will have their certificate of registration revoked and will be required to re-apply for registration and go through the same process as new applicants.

#### *Registered Optician certificate suspended for non-payment of fees (under 3 years)*

This section applies to registrants who held a certificate of registration as a **Registered Optician** and that certificate was suspended for non-payment of fees/non-renewal within the last 3 years.

Registrants in this category are only eligible to reinstate back into the Registered Optician class. Opticians wishing to transfer to the Inactive class may do so after they reinstate their certificate of registration as a Registered Optician.

In order to have the suspension lifted, Registered Opticians whose certificate of registration has been suspended for less than three years must:

1. Submit a completed application form to the College.
2. Be in compliance with any outstanding orders of the College's Committees or Board of Directors.
3. Provide proof of professional liability insurance.
4. Provide any outstanding information and pay any outstanding fees to the College.
5. Pay the reinstatement fee and the registration fee for the Registered Optician class of registration.

*Inactive Class certificate suspended for non-payment (under 3 years)*

This section applies to registrants who held a certificate of registration as an **Inactive Optician** and that certificate was suspended for non-payment of fees/non-renewal within the last 3 years.

Registrants in this category are only eligible to reinstate back into the Inactive registration class. Once their Inactive certificate is re-issued, any opticians wishing to transition to the certificate of registration as a Registered Optician may follow the process outlined below for returning to active practice from Inactive to Registered Optician class.

In order to have the suspension lifted, Inactive Class registrants whose certificate of registration has been suspended for less than three years must:

1. Submit a completed application form to the College.
2. Be in compliance with any outstanding orders of the College's Committees or Board of Directors.
3. Provide any outstanding information and pay outstanding fees to the College.
4. Pay the reinstatement fee and the registration fee for the Inactive class of registration.

*Registered Optician certificate Suspended for non-payment of fees (over 3 years) - TRANSITION POLICY*

This section applies to registrants who held a certificate of registration as a **Registered Optician** and that certificate was suspended for non-payment of fees/non-renewal more than 3 years ago.

Under the Registration Regulation, opticians whose certificate of registration has been suspended for non-payment of fees may remain suspended for a maximum of three years. Opticians who do not reinstate their registration will have their certificate of registration revoked at the end of the three-year period.

As a transitional provision, the College will accept applications for reinstatement from individuals whose certificate of registration was suspended more than 3 years ago and who wish to avoid revocation. Individuals who are not reinstated by July 1, 2025 will be revoked.

Registrants in this category are only eligible to reinstate back into the Registered Optician class.

Registrants who wish to remain in the Registered Optician class must take the following steps to have their suspension lifted:

1. Submit a completed application form to the College.

2. Complete a competency assessment as set or approved by the Registration Committee.
3. Be in compliance with any outstanding orders of the College's Committees or Board of Directors.
4. Provide proof of professional liability insurance.
5. Provide any outstanding information and pay outstanding fees to the College.
6. Pay the reinstatement fee and the registration fee for the Registered Optician class of registration.

Registrants who wish to immediately transfer to the Inactive class must take the following steps to have their suspension lifted:

1. Submit a completed application form to the College.
2. Be in compliance with any outstanding orders of the College's Committees or Board of Directors.
3. Sign an undertaking not to practise opticianry while holding a certificate of registration as Inactive Optician.
4. Provide any outstanding information and pay outstanding fees to the College.
5. Pay the reinstatement fee and the registration fee for the Inactive Optician class of registration.

This Transition Policy will remain in effect until July 1, 2025.

### Changing from the Inactive Class to the Registered Optician Class

This section applies to registrants who hold a certificate as an **Inactive Optician**. The certificate must be current and cannot be suspended for non-payment of fees/non-renewal. Inactive Opticians holding a certificate that has been suspended must first reinstate their certificate before requesting to change to the Registered Optician class (see the section on Reinstatement, above).

To change from the Inactive Class to the Registered Optician class, registrants must:

1. Submit a completed application form to the College.
2. Demonstrate that their opticianry knowledge and skills are current (see *Knowledge and Skill Requirement* section below).
3. Pay any outstanding fees to the College.
4. Provide evidence of professional liability insurance.
5. Pay a status change fee and registration fee (a prorated Registered Optician fee will apply).

### *Knowledge and Skill Requirement*

In order to resume active practice, Inactive Opticians will be required to demonstrate that their knowledge and skills are current. This can be demonstrated by meeting at least one of the following requirements:

1. **Practice Hours:** Providing evidence of having engaged in at least 500 practice hours within the last three years. Opticians who have been inactive for less than 3 years can include practice hours that were acquired while they held a certificate as a Registered Optician.

Practice hours acquired as a Registered Optician in Ontario within the last 3 years can include:

- a. Dispensing of eyeglasses, contact lenses and subnormal vision devices, and related duties (e.g. record keeping, laboratory work, cleaning and disinfecting eyewear, optical appliances, tools or equipment).
- b. Teaching opticianry at an accredited opticianry program in Canada.
- c. Supervising student and/or intern opticians.
- d. Directly supervising, managing or assuring the quality of services of opticianry staff engaged in dispensing.
- e. Completing advanced learning courses (including certificate programs) in opticianry or optical sciences at an educational institution accredited by the College (see [website](#) for a list of institutions).
- f. Completing continuing education activities accredited by the College.
- g. Presenting continuing education activities that have been accredited by the College (presentations that are delivered on multiple occasions may only be counted once).
- h. Completing up to a maximum of 4 hours per year of self-directed continuing education activities annually.

Practice hours acquired as an Inactive Optician\* can include:

- a. Dispensing of eyeglasses, contact lenses and subnormal vision devices, and related duties (e.g. record keeping, laboratory work, cleaning and disinfecting eyewear, optical appliances, tools or equipment) in another jurisdiction.
- b. Teaching opticianry at an accredited opticianry program in Canada.
- c. Supervising student and/or intern opticians in another jurisdiction
- d. Directly supervising, managing or assuring the quality of services of opticianry staff engaged in dispensing in another jurisdiction.
- e. Completing advanced learning courses (including certificate programs) in opticianry or optical sciences at an educational institution accredited by the College (see [website](#) for a list of institutions).
- f. Completing continuing education activities accredited by the College.
- g. Presenting continuing education activities that have been accredited by the College (presentations that are delivered on multiple occasions may only be counted once).
- h. Completing up to a maximum of 4 hours per year of self-directed continuing education activities annually.

2. **Refresher/Upgrading:** Completing a refresher or upgrading program that the Registration Committee has set and approved.
3. **Professional Competency Assessment:** Undergoing a professional competency assessment and completing any refresher or upgrading courses assigned by the Registration Committee as a result of the competency assessment.

\*In Ontario, Inactive Opticians are not permitted to dispense prescription eyewear (including under the supervision or delegation of another optician, optometrist or ophthalmologist) or supervise student/intern opticians.
