1. **THIS COURT ORDERS** pursuant to subrule 38.09(4) of the *Rules of Civil Procedure* that the Applicant may dispense with compliance with the requirement in subrule 38.09(1) to serve and file a factum.

- 2. **THIS COURT ORDERS** that Tony Frisoli and anyone employed by or otherwise acting on his behalf comply with sections 4 and 9 of the *Opticianry Act*, 1991 and section 27 of the *Regulated Health Professions Act*, 1991 and, in particular, that Tony Frisoli cease and desist:
 - (i) holding himself out as a person who is qualified to practise in Ontario as an optician, and
 - (ii) performing any controlled acts including dispensing subnormal vision devices, contact lenses or eye glasses.
- 3. THIS COURT ORDERS that the Respondents comply with section 42 of the Regulated Health Professions Act, 1991 and, in particular, that the Respondents cease and desist employing any person who performs controlled acts unless the person is a member authorized by a health profession Act to perform the controlled act or the performance of the controlled act has been properly delegated to that person.
- 4. **THIS COURT ORDERS** the Respondents to pay costs to the Applicant, on a joint and several basis, in the amount of \$5,000.00 within 30 days of the date of this Order.
